WHY THE NEED FOR GOVERNANCE AND STEWARDSHIP?

- Because the committee has a role in the territorial vision

- Because the status quo is no longer possible against the backdrop of budget cut and transfer of responsibilites by the government.

ANSWERS

What impact does governance and stewardship have on my sector of activity?

- Reduction of services
- Many regulations
- Disincentive for entrepreneurship
- Loss of funding
- Obligation to speak with all the municipalities in order to work on files that affect the territory
- Inadequate funding of services
- Impact on cooperation

ANSWERS

Can governance and stewardship of the territory be improved?

- Be involved and open to change
- Conduct more consultations to better understand the issues
- Develop partnerships
- Be able to recognize that territorial services and equipment do exist
- Reduce the number of elected representatives and group together services.
- Have more young people and women on municipal councils.
- Clarify the roles and responsibilities of everyone.

ANSWERS

Do you believe there should be municipal reorganizations in Temiscamingue County?

- Risk of centralization
- Grouping instead of mergers, sharing of costs
- By sector or according to proximity
- Grouping of services and even some municipal mergers
- Mergers by sectors or municipalities that are close to each other
- One MRC = One City with districts
- Simplify the current structure
- Act quickly
