## INFORMATION

1. Personal information is collected for the purpose of enforcing the laws, regulations and programs under the authority of the Minister of Natural Resources.
2. The MRC will only issue a lease to one individual or one incorporated legal person. In the case of a group of individuals, a representative must be appointed and the lease will be issued in that representative's name. It is up to the members of the group to come to an agreement among themselves.

In the case of a lease for a non-profit community purpose, the applicant must be a legal person.

3. A non-refundable processing fee of \$120 plus GST and QST (\$137.97) is required at the time of application. This fee can be paid in cash or by Interac at the MRC office, or by cheque or money order payable to the MRC de Témiscamingue.
4. An administration fee of \$366 plus GST and QST (\$420.81) will be required for the rental or purchase of land in the domain of the State, the exchange of land or the granting of any other right with the exception of an authorization for the construction of a road other than a forest or mining service road, a parking lot, a rest area without services or a boat launch access road.
5. An administration fee of \$366 plus GST and QST (\$420.81) will be required for the examination of an application to rent or purchase land of more than one hectare for commercial or industrial purposes.
6. The above-mentioned fees are those in effect as at April 1, 2022 and will be adjusted and rounded off to the nearest dollar on April 1 each year based on the changes in the average consumer price index for the preceding year, using the index established for the whole of Québec by Statistics Canada.
